Regarding the item 1 of the agenda, Results, Organization and Financial Report 2014, the President D. Sauvaire and the Secretary General P. Silva addressed the assembly on the subject and focus was placed on:

• The financial organization, the support of the UWW with a grant of € 10,000;

- Interventions and organization of CMLA (CMLA office and AG Kanjiza)
- Balance of the Mediterranean Championship in Kanjiza with a participation of 18 countries.

It was approved unanimously the report, the operating account and the financial statement 2014.

On the item 2 of the agenda, Program and Budget for 2015, the President and the Secretary General addressed the assembly on the document "Activity, Plan and Budget 2015," which was sent in due time to all countries.

The program was comprehensive, the focus has been on the Bureau's decision and the assembly to support the development and training through various actions, namely:

- Support for training of referees, support for training of coaches and the establishment of a youth training camp;
- Information was given on the Bureau's decision to support the participation of countries in the championship: Montenegro, Palestine, Lebanon and Syria.

The plan and budget were presented and approved unanimously by the assembly.

Regarding the item 3, Calendar for 2016-2017, the President and the Secretary General addressed the subject, and reinforced the need to quickly put in the United World Wrestling calendar the Mediterranean championships.

It was noted the difficulty to propose dates on a very busy calendar in 2016, with the Olympic qualifying tournaments, the continental championships and the Olympics.

It was addressed the situation to revive and to contact countries to discuss with them a candidacy, the organization and support of the CMLA.

It was discussed the possibility of organizing a youth championship (cadets and juniors under 23) in February, March or mid-June and a Senior Championship in November with possibly a young class.

It was noted that to date:

- Only the City of Tarragona, Mediterranean Games host city in June 2017, applied a bid to host the Mediterranean Championship in late October or early November 2016;
- It was asked to revive a consultation to countries;
- Kamel Bouaziz proposed together with the Presidency of the Federation for an organization in Tunis.

It was recalled:

- The need to maintain an board and lodging tax near of 60 €;
- The need for the participation and for a larger representation of countries in all styles.

Following the intervention of Italy which wishes the championship is growing and attracts more countries by offering a reward or endowment to best teams. This proposal was shared by the countries and received a favourable opinion.

He was granted discharge to the office to find and propose a solution with a regulation that encourages countries to participate and respect of ethics and sport.

On the item 4 of the agenda, Organization and functioning of the commissions, the President and the Secretary General did an intervention where it was given the role and organization of the various committees. It was announced that CMLA received proposals of member integration from Egypt, Spain, Greece, France and Portugal.

A raise shall be made by the office and coordinators of each committee. It was given as goal that Teresa Mendez animates Women and Sport Commission and that Kamel Bouazis animates the Refereeing Commission and shall organize a seminar.

A proposal for action of the Medical Commission was made by Dr. A. Chahi. He also made an intervention on doping and health and sports issues. He supports the animation and mobilization of federation doctors.

Regarding item 5 of the agenda, Partnerships and Communications, the Vice-President Rajko Baltic and the President of Business Club Mr Slobodan Petrovic addressed the assembly regarding what was done so far and the plans for the future.it was also made a request for mobilization of the Federations and the importance of developing a partnership, because all major federations have a network of economic and institutional players. It was underlined that in the Mediterranean, wrestling can be a powerful economic driver.

It was also presented an assortment of marketing and communications objects: t-shirt, ties, pins, plates, medals.

On the item 6 of the agenda, miscellaneous, both the President and the Secretary General did interventions on various items but the focus was placed on:

- The support of organizations like the CMLA medical forum (invitation of Dr. Carole Master CNOSF and INSEP on two topics "Women and Sport) and the International Tournament of Olympia;
- Was done a presentation of Beach Wrestling with Beach Games wrestling organized by the ICMG. It was expressed the wish of a strong participation by Mediterranean countries;
- The issue of granting visas was addressed and the need to establish a procedure to facilitate its obtaining.

To close the Assembly was read a letter of support from the United World Wrestling President Nenad Lalovic.
